The Victoria College Board of Trustees met Monday, August 26, 2019 at 4:00 p.m. in the Corporate Training Room - 101 of the Academic Building.

A. Call to Order:

- 1. Mr. Bland Proctor called the meeting to order at 4:00 p.m. and announced that a quorum of board members was present.
- 2. Dr. David Hinds certified that the agenda had been properly posted per Texas statute.

B. Citizen Communication:

- 1. Mr. Proctor invited attendees wishing to speak to the board, on items other than the proposed tax rate, to come forward. No comments were made.
- 2. Mr. Proctor officially opened the 1st Public Hearing. There were two visitors present to address the board, Mr. Todd Brown and Mr. Harold Mallory. Mr. Brown expressed his concern over the proposed tax rate, increased taxes and the financial state of the college. Mr. Mallory also shared his concern over increased taxes and recommended the Board consider holding their meetings later in the day so more citizens would have the opportunity to attend. Board members thanked Mr. Brown and Mr. Mallory for their comments. They assured everyone that the college is financially sound and audited annually by an external firm. They shared that they don't take the assessment of a tax or the raising of student tuition and fees lightly, but over time, the State has reduced its share to fund the cost of higher education. They commended the college administration for their work in reducing expenses as much as possible and presenting a budget that is approximately \$372,000 less than the prior year. With no other comments from the

attendees, Mr. Protor closed the public hearing.
