- Be a Texas Resident
- Must be registered for Selective Service or be exempt from this requirement
- Submit all required documents at least 30 days prior to the first class day
- Enroll in an approved course as determined by the CTE-CE or AHCE Department.
- Returning students on Enforced Withdrawal or Disciplinary Probation are ineligible.

PRIORITY COMPLETION DATE: 30 days prior to the class start date

REPAYMENT POLICY: You must contact the Career & Technical Education – Continuing Education Office or the Allied Health Continuing Education Office prior to withdrawing from coursework. If you withdraw from your class, you may have to repay your award. You will be ineligible to receive TPEGCE for any additional course(s) until your balance is repaid in full.
