Testing Requirements

Mathematics is crucial to engineering and vital in helping engineers analyze models, predict outcomes, and make informed decisions. To ensure students can enter into their math course rotations and meet prerequisite requirements for necessary science courses, TSI completion in math, or equivalent testing, is required for admission. The following options are available:

- 1) Submit qualifying Test Scores (view the [VC Catalog](#) for required state testing)
- 2) Schedule an appointment with the [Testing Center](#) to take the TSI Assessment
- 3) Complete a [Conquer Math, The Pirate Way](#) extended workshop. This **FREE** extended workshop:
 - is designed to equip students with the skills and confidence needed to complete their math testing requirement.
 - is an 8-week summer program that takes place Monday through Thursday from 9 a.m. to Noon.
 - provides one **FREE** TSI Assessment per participant during the 8th week.
